In view of the references 1" & 3" cited, and basing on the enquiry report vide ref. 4th cited, that untoward incident has took place at KGBV, Devaruppula. Mdl Devaruppula on 27.10.2022 regarding food poison and the students who took the dinner in the school with the curry of Dosakaya (Cucumber) has found the House gecko (Lizard) in the curry and the (12) students are admitted in the Govt. Area Hospital, Jangaon for treatment.

After careful examination and the basing on the enquiry report of the committee, it is noticed that, Smt. N. Renuka, Asst.Cook, KGBV, Devaruppula has failed to perform her legitimate duties and shown gross negligence and for cause the incident took place on 27.10.2022 at KGBV Devaruppula.

In view of the above circumstances, and as per the nate orders approved by the District Collector & Chairman, SS TS Jangaon vide ref. 5th cited, the services of Smt. N. Renuka, Asst.Cook, KGBV, Devaruppula Working on contractual basis is hereby terminated / removed from immediate effect. The Special Officer, KGBV, Devaruppula is instructed 🐲 not to utilize the services of the above said individual with immediate effect.

We submit that, anuntoward incident has took place at KGBV, Devaruppula, MalDevaruppula on 27.10.2022. The school is functioning with enrollment of 122 out of which 91 are present. As a regular time schedule, the students took the dinner in the school. In this connection, the curry Dosakaya (Cucumber) was cooked and students who took the meals have informed to the staff of the school that, a House gecko was found in the curry of Dosakaya (Cucumber), Accordingly, serving of the meals to the remaining students was stopped.

Meanwhile, the (12) girl children who have already consumed the mealswent to the panic situation. In view of this, the incharge teacher and staff have taken the students to the Govt. Area Hospital, Jangaon. The students have been admitted in the Hospital for observation and treatment.

We submit that, as per the instructions of Hon'ble District Collector & Magistrate, Jangaon today i.e. 28.10.2022, the Revenue Divisional Officer, Jangaon and District Educational Officer, Jangaon, District Medical & Health Officer, Jangaon have visited and inspected KGBV Devaruppula and interacted with the students, staff, parents and Local representatives regarding the above said matter.

The following findings are noticed in Enquiry:-

- The cooking staff daily cook the food and leave the KGBV without serving the food to students. On the day of the incident i.e.27-10-2022 the children took the meals at ainner time by themselves as the cooking staff already left away the school. This shows gross negligence in their regular duties.
- The kitchen room is with open windows, doors and there are no proper meshes. The Kitchen waste disposal has no proper outlet and there is no lighting facility in the kitchen room.
- > There is failure in proper supervision by the staff concerned in the school during the dinning hours.
- The food is not served as per the prescribed menu. On questioning the matter, the workers of the school mainly Smt. B. Jyothi. Asst. Cook is threatening the students.

- Smt. B. Manjula, Head Cook , Smt. B. Jyothi, Asst. Cook and Smt. N. Renuka, Asst. Cook of KGBV are not maintaining the timings as per the duty roster. Lack of hygiene while preparing and serving.
 - The students said that, the food is not cooked properly and they also complained that they found insects in cooked food some times.
 - > The raw material which is used to cooking is not stored properly.
 - Cleanliness in the cooking area, dining area is very poor and as such, the insects etc are falling in the cooked food items.
 - > Some Parents complained that, funds are being collected for development of minimum facilities in the KGBV as per the resolution of the parents committee, but the facilities are not provided.
 - > The CC Cameras installed in the KGBV are not working.
- > Wash rooms maintenance is very poor in the school.
- > The staff is using Mobiles in the school and kept busy with its activities.
- > The above said cooking staff (03) of KGBV are frequently quarreling with the Special Officer of KGBV and staff.
- > There is no proper supervision of Special officer and staff on the students while having their usage of washrooms, Toilets,
- The Night watch women i.e., Smt. B. Bujjamma, is Only available in the school and responding properly to the parents who visit KGBV and the remaining staff are not responding properly.

After thorough verification and inspection of the Enquiry committee the following observations are made:

- There is lack of coordination between the Special officer and staff working in KGBV Devaruppula.
- There is gross negligence in performing the routine duties of the following (03) staff which resulted to the untoward incident took place on 27-10-2022.
 - (i) Smt. B. Manjula, Head Cook,
 - (ii) Smt. B. Jyothi, Asst. Cook,
 - (iii) Smt. N. Renuka, Asst.Cook

Hence, the request of the parents of the school children for removal of the above said cooking staff may be considered and necessary action may also be taken to respect of improvement above amenities as proposed above.
